





Whereas, the Trust deed pertaining to "Arka Educational and Cultural Trust" containing the objects of the Trust, Trust Fund, the Rights and duties and power of Trustees or Board of Trustees and the Account of Trust etc., has been registered in the Office of Sub-Registrar, Basavanagudi, Bangalore as Document No.00138/2009-10 in Book-IV and stored under C.D.No.123 on 21.11.2009.


Whereas, after coming into force of "Arka Educational and Cultural Trust" considerable progress has been achieved by the Trust headed by the present four trustees including the Author of the Trust. However, the Board of Trustees have decided to add a Clause with respect to acquisition on immoveable properties and pledge them to raise funds etc. This Clauses shall be included in the Parent Trust Deed dated: 21.11.2009 by way of amendment. In this background, the Board of Trustees have decided in their Board meeting held on 15.05.2012 to add the following Clause by amending relevant clause in the original Trust Deed dated 21.11.2009, to suit the present requirement of Trust and accordingly authorized Sri. R. Chenraj Jain, the Author of the Trust and now trustee of the Trust and other three Trustees of the Trust mentioned above to execute this Deed of Amendment of Trust.

Now this Deed of Amendment of Trust, witnesseth as follows:-

After Sub-Clause "i" in Clause No.4, at page No.4 of original Trust deed dated: 21.11.2009, a new Clause "j" shall be inserted (by replacing the existing clause "j" as "k") as "D. To acquire on lease by purchase or otherwise, to sell,









mortgage, to lease out or transfer in any other manner, properties moveable or immoveable to construct buildings and other improvements for the purpose of Trust and to manage and to deal with properties, moveable or immoveable and all other assets of Trust and to pledge them to raise funds to repay loans or otherwise and to deal generally with the assets for the purpose of the Trust" and the existing Sub-clause No."j" shall be renumbered as Subclause No. "k" in Clause No.4 at Page No.4 of the Principal Trust Deed.

Whereas, except the above amendment, all other clauses of the Principal Trust Deed dated: 21.11.2009 remained unaltered and would be in force in the same spirit.






